■ Presentation

Are you a foreign student who wants to enroll for a Master's Degree in Business Law at a French University? At the Université de Franche-Comté, the Faculty of Law, Economics, Political Science and Management (l'UFR Sciences juridiques, économiques, politiques et de gestion - SJEPEG) offers you a training program which will give you the best chance for success in your studies and allow you to obtain an advanced University graduate diploma.

■ Objectives

The 'UFR SJEPEG' offers a training program designed for foreign students who would like to enter its Masters 2 in Business Law program, or another one at another French university. This program lasts for one academic year and leads to: a foundation program University graduate diploma.

In order to meet the needs of students who haven't studied law at French university, this program focuses on enabling students to master the following:

- the concepts of business law and how it is practiced,
- the method needed to meet the requirements of a Masters 2 program,
- the keys to understanding European Law and International Business Law.

This diploma is implemented thanks to a collaboration with the CLA (Center for Applied Linguistics), a quality labeled center for ‘French as a foreign language’, which guarantees the excellence of its French-language training programs and a top quality welcome for students.

■ **Requirements:**

- Students must have a diploma certified as equivalent to a Masters 1 diploma level (French ‘maîtrise’) in the field of their selected speciality
- Students with a certified C1 level in French
- They must have a A2 level for general English and a B1 level for business English
- **Prerequisite:** the DSU is open to students who know the continental European Law system and not only the Common Law system
